CRITICAL INTERSECTIONS OF CRIME AND SOCIAL JUSTICE CONFERENCE

Old Dominion University, April 7-8, 2017

Social inequalities structure our lived experiences of crime and the criminal justice system. Intersections of race/ethnicity, gender, class, sexuality, nationality, and other critical social dimensions condition the multiple realities of crime and justice. The search for social justice requires interrogation of harm in its many forms, whether recognized as crime or not. The struggle for social justice also calls forth community in acts of resistance and (re)building. A growing number of scholars working in various criminological camps – often under critical, feminist, anti-racist, and queer criminologists – envision their scholarship as a part of this struggle. While the number of criminologists doing social justice-oriented work has arguably never been greater, there remain few venues for progressive and critical scholars of crime and punishment to share ideas, frustrations, and inspirations. The aim of this conference is to provide such a venue in hopes of reinvigorating intellectual and policy debates about the links between social justice and issues of crime and punishment.

Critical Intersections of Crime and Social Justice is modeled on the "New Directions in Critical Criminology Conference" held at the University of Tennessee, Knoxville in May 2016. Building on the success of that conference, we welcome scholars, students, practitioners, and activists to Old Dominion

University in Norfolk, Virginia, April 7-8, 2017. With this conference, we hope to create a space that sparks dialogue about how matters of crime and punishment intersect with issues of social injustice and how our field can throw light on those intersections and work to bring about greater equality. Keynote speakers at the event will include Hillary Potter, Judah Schept and Elliott Currie.



DPCC 2016 Luncheon Symposium Keynote Speaker

U.S. Attorney Kenneth A. Polite, Jr.



On September 20, 2013, after being nominated by President Barack Obama and unanimously confirmed by the U.S. Senate, Kenneth A. Polite was sworn in as the U.S. Attorney for the Eastern District of Louisiana. In that capacity, he serves as the chief federal law enforcement officer for the 13 parishes comprising Southeast Louisiana. In April 2015, Attorney General Lynch appointed Mr. Polite to serve on the Attorney General's Advisory Committee ("AGAC"). The AGAC serves as the voice of the 93 U.S. Attorneys across the nation and

provides advice and counsel to the Attorney General and other senior leaders in the U.S. Department of Justice on policy, management, and operational Prior to becoming U.S. Attorney, Mr. Polite was a shareholder at issues. Liskow & Lewis, where he headed the white collar criminal defense group and served as the Firm's hiring partner. From 2007 to 2010, Mr. Polite served as an Assistant U.S. Attorney for the Southern District of New York, where he prosecuted a wide range of federal criminal offenses, including organized crime and public corruption. Mr. Polite previously served as an associate in the New York and Delaware offices of Skadden, Arps, Slate, Meagher & Flom, LLP. Mr. Polite is a graduate of De La Salle High School in New Orleans (valedictorian), Harvard University (A.B., Government), and Georgetown University Law Center (J.D., cum laude). While in law school, he served as Editor-in-Chief of the American Criminal Law Review's Fifteen Survey of White Collar Crime. Following law school, Mr. Polite served as a judicial clerk for the Honorable Thomas L. Ambro, Circuit Judge for the United States Court of Appeals for the Third Circuit. Mr. Polite is married to Dr. Florencia Greer Polite, and together, they have two beautiful daughters, Gabrielle and Lena.

Please participate in the Be the Match Bone Marrow Registry drive on **Friday, November 19, from 10 a.m. to 4 p.m.** at the Hilton Riverside hotel. Be the Match will have a table right next to the Division on People of Color and Crime in the Chemin Royale main hallway (where all the division tables will be). It's easy to register and it only takes a cheek swab, but you may be able to save a life as a bone marrow donor.

This is a special event inspired by our colleague, <u>Alexes Harris</u>. You may know her as a Professor of Sociology at the University of Washington, author of the book, <u>A Pound of Flesh: Monetary Sanctions as a Punishment</u> for the Poor (Russell Sage, 2016), public intellectual and policy influencer. On top of all that, Alexes is a great friend, mom of two young kids, and loving wife.

In May 2016, Alexes was diagnosed with a rare blood cancer called myelodysplastic syndrome. She learned that her only hope for recovery would be a bone marrow stem cell transplant. She had a tough time finding a match due to her mixed-race background. It turns out that the chances of finding a bone marrow donor match are much lower for people of color than for white patients. In the end, Alexes was able to have an <u>umbilical cord blood transplant</u>, but this inspired her to use her story to motivate others to register for the national bone marrow registry.
