Feminist Criminology and International Criminology (DIC): Special Issue

Dear colleagues,

On behalf of the Division of International Criminology (DIC), I'm reaching out to discuss an idea that emerged during our recent Executive Board meeting in response to ASC President, Dr. Katheryn Russell-Brown's encouragement to explore cross-division collaboration within ASC.

We are considering developing a special issue in *International Criminology* (IC) that would highlight the contributions of ASC divisions to international and comparative criminology. The theme would focus on examining the past, present, and future roles of ASC divisions in advancing internationalization within the field.

The special issue would serve as a platform to showcase diverse perspectives across divisions on global and comparative criminological challenges and opportunities. Contributions could address topics such as how division-specific areas intersect with international criminology, successful international partnerships, and pathways for advancing cross-national collaboration in the years ahead.

We believe this initiative could foster meaningful engagement between divisions, build stronger connections across the ASC community, and amplify the international scope of ASC scholarship.

At this stage, we are seeking input from division chairs regarding potential interest in contributing to this special issue. Specifically, we'd like to hear:

- Ideas for division-specific topics or themes that could be included in the special issue;
- Suggestions for contributors or key issues to address;
- Feedback on whether this initiative aligns with the division's goals and priorities.

We're also aware of feedback from Ineke Haen Marshall and Janet Stamatel, the editors-inchief of *IC*, regarding the importance of refining the theme for the special issue to ensure clarity and focus. We welcome your input to help shape a cohesive and impactful theme for this endeavor.

Your insights will be invaluable as we continue discussing this proposal and developing a structured plan at our next DIC Executive Board meeting in February. Please feel free to share your thoughts or let us know if additional information is needed.



Thank you for considering this opportunity for collaboration. We look forward to working together to strengthen the international focus of ASC divisions.

Apologies for the delayed reply, we had an event a few days ago and we've been strategising for our next steps. Much of our energy has been focused on that.

Nonetheless, we received your email and definitely think it's timely, especially given the DPCC 30 year anniversary - more than happy to support where we can.

Beyond our consulting and supporting capacities, we've developed a series of event types:


- **Network and Learn** These are informal sessions (monthly) for members to connect with one another and platform their research. They're usually held online and were the first event type we had. We're also looking to reinvigorate these.
- Sisterhood Unlocked These are usually held in parallel to International Women's
 Day and serve as a safe space for Black women around the world to come together
 to share research, their woes and embrace sisterhood. We're in the process of
 arranging one for March
- The Masterclass This is an in-person session (Winter) where we invite someone that has extensive experience to deliver an input/teach/workshop on a particular theme. In our last one we featured Dr Martin Glynn (UK based) and he focused on "how to conduct research on Black histories in the criminal justice system". We haven't delivered one since 2022 but are considering to have them return.
- The Symposium This is the most recent event type we've delivered and the primary aim is to provide a space to enhance collaboration and learning between industry professionals, academics and researchers. We successfully delivered the first one on Thursday with a theme of "youth, crime and justice". We're working on what 2026's symposium will look like.

With the above event types in mind, we think the one that may align best with what you and the DPCC have in mind and the broader ASC landscape, is The Masterclass. This might be a way of ensuring attendees can learn something tangible from someone with a strong legacy in the discipline, celebrate the individual and also promote the idea of longevity. Albeit, we're open to your thoughts.
