## VII. DPCC 2025 Board Priorities

- **DPCC @ 30!**
  - Dr. Helen Teller Green, Dr. Delores Jones Brown, and Dr. Lorna Grant expressed interest working with the original charter members to help capture the oral history story project.
  - Possible charter member to serve as Keynote Speaker
  - DPCC @ 30 swag: sweatshirts, etc.
  - Identify a chair or co-chairs for the DPCC 30th anniversary committee by February 1st.
  - Put out a call in the January newsletter for members to volunteer for committee.
  - Oral history: ask members over the last 30 years to discuss the influence of the DPCC, gather quotes to display at luncheon/awards.
  - Campaign leading up to ASC, highlight an individual quote and how the DPCC has influenced them.
- **Develop charges for standing committees and recruit volunteers for the following committees.**
  - Nominations and Elections
  - Constitution and Bylaws
  - Awards and Nominations

**Summary:** Develop committees of possibly 4 people.
- **Communication and Outreach**
  - January newsletter
    1. Highlight incoming DPCC executive board members
    2. Short bios of new board members included in newsletter
    3. Ask for volunteers for DPCC @30.
    4. Highlight images from last DPCC luncheon
    5. Upload older newsletters to the website
  - Social media: Goal for media fellow to manage website and social media
    1. Send out call to more departments with PhD students and preferably a student in the field of criminology/criminal justice.
    2. There's a need for additional help in updating the website and improving the stagnant social media presence.
    3. A student in the discipline could be more beneficial due to their understanding and networking potential.
    4. Media fellow position comes with a substantial stipend.
- **Race and Justice Journal (RAJ):** Possibly capture oral history reports to be placed in the RAJ journal.
